The owner reserves the right to accept or reject any or all bids, and to waive any irregularities in bidding. Base bids may be held for the following period before award of Contract: Ninety (90) Days

Proposals shall be properly and completely executed on the Bid Form provided. The Contractor shall state in his bid the number of calendar days required to complete the project, if different from the schedule stated on the Bid Form.

Should a successful Bidder withdraw his bid or fail to satisfactorily execute all of the requirements and enter into a written Contract within ten (10) days after notice of acceptance of his bid, the Owner may declare the Bid null and void and the Bid Security forfeited, not as a penalty, but as liquidated damages.

The successful Bidder shall furnish a Performance and Labor and Material Payment Bond from an approved surety company, which will remain in full force and effect for a period of two (2) years after date of final acceptance of work. Performance and Labor and Material Payment Bond shall be in an amount equal to the following percentage of the Contract Sum:

One Hundred Percent (100%)
