“REVISED” EXHIBIT A SCOPE OF WORK

1. General Provisions

The vehicle must comply fully with the specifications of the order, and ensure the vehicle is free from defects.

2. Objectives

CATA considers the Contractor’s ability to plan, communicate and execute this procurement as a requirement of the award of this contract.

3. Service Period

CATA intends to award a firm, fixed price contract.

4. Scope of Work

The Capital Area Transportation Authority (“CATA”) is requesting quotations from vendors for the purchase of a 2019 or newer Ford F-550XL Chassis Cab Truck with up fit or approved equal.

The required specifications are listed below:

Description:	One new Ford F-550XL Chassis Cab Truck, 2019 or newer equipped with a Knapheide Fleet Road Service Steel Truck Body, with Front Push Bumper, Electric Winch, Start-All 12/24 with air, Metal Fluid containers, Emergency Lighting and Hydraulic lift gate, and other accessories or approved equal.
Model:	Ford F-550-XL, DRW, Regular Cab, 169” wheelbase, CA 60” or approved equal.
Exterior Color:	Oxford White
Interior Color/Type:	Medium Earth Gray HD Vinyl 40/20/40 Split, No Carpet, AM/FM Stereo, USB Ports

Hook up air fittings and quick connect color/voltage coded cable quick disconnects. Start-All mounting to be decided after award either cabinet top or bed mounted. Two (2) 20' jumper cables.
- One (1) Knapheide Lube skid bed mounted or approved equal, turnkey system, three (3) 20 Gal tanks-diesels, coolant, engine oil. 12V pumps, 50' hoses, retractable reels, 1/2" and 3/4" hoses, fuel filter, manual nozzles, and mechanical meters. Skid bed mounting location to be determined after award.

Price quoted will include all fees. Price for the vehicle registration should be based on CATA's status as a tax exempt, municipal government agency.

The bid cost of the complete vehicle shall include all related transportation costs for the vehicle to be delivered to CATA at 4615 Tranter Street, Lansing, MI, 48910. The vehicle must be clean, interior and exterior, and delivered with a full tank of gasoline.

Payment shall be made as follows: 80% upon delivery of the completed vehicle to CATA facility; 20% upon full acceptance. Acceptance shall be made within 10 days of the receipt of the vehicle, **providing the vehicle meets CATA specification compliance and passes CATA's acceptance inspection.**
